Segregated C&D (concrete, treated wood, fencing material, etc.) (per ton)	\$30.90
Segregated Yard Waste (grass clippings, small brush, leaves, etc.) (per ton)	\$30.90
Non Friable Asbestos (per ton)	\$45.90
Minimum charge for loads (up to 480 pounds)	\$8.48
Petroleum Contaminated Soils, Sludge, Other Permitted Soils (per cubic yard)	\$8.00
Animal, Large [e.g. Sheep, Goat, Horse, Cow, etc.] (per each)	\$17.50
Animal, Small [e.g. Cat, Dog, Skunk, etc.] (per each)	\$4.50
Animal Offal [e.g. Butcher leavings] (per container up to 55 gal)	\$9.50

Flat Bed City Cleanups (per 2000 pounds) (Municipal Rate Only)	\$28.00
Unloading past 4:15 PM (per load) (without appointment) per 30 minutes increments	\$25.00
Illegal disposal or dumping charge [Minimum] Additional charges may be assessed.	\$100.00
Cleanup of unacceptable, illegally dumped or hazardous wastes	1 ½ times total cost of cleanup & disposal
Unsecured loads or material visibly falling off or out of the vehicle even tarped or tied (per load)	\$10.00

Colorado State Surcharge: State Surcharges of \$0.90 per ton, \$0.27 per cubic yard, or \$0.17 per vehicle for only animal, appliances or tire disposal are in addition to the above listed charges to fund the Recycling Resources Economic Opportunity Fund (RREOF), Hazardous Substance Relief Fund (HSRF) and Solid Waste Operational Fund (SWF).

4Corners Recycling Initiative: Old Corrugated Cardboard (OCC), Old Mixed Paper (OMP), Metal Food/Drink Cans

No charge for clean, segregated (sorted) material placed in green bins or arranged for large quantity of segregated material

Volume Discount for Commercial Haulers (including state surcharge): average tons/month based on a calendar quarter

0 to 750 tons/month (calendar quarter)	\$34.30	per ton
750 to 1100 tons/month (calendar quarter)	\$32.55	per ton
1100 to 1400 tons/month (calendar quarter)	\$31.55	per ton
Over 1400 tons/month (calendar quarter)	\$30.80	per ton

Outgoing Material

Unprocessed Compost/Wood Chips:	\$10.00 per ton (\$5.00 minimum)
Landfill loading fee (Landfill equipment used)	\$5.00 per load <5 cubic yards, \$10.00 per load >5 cubic yards
